You are cordially invited to submit an abstract for a presentation or a research paper to the 2012 Global Supply Chain Management Conference, hosted by the State University of New York, College at Plattsburgh from Monday, June 11 to Tuesday, June 12, 2012 in Plattsburgh, New York, USA. The conference is accepting presentations, research papers, case studies & white papers that can take the form of:

- the submission of an abstract for a research presentation (unpublished)
- the submission of a full paper for presentation and publication in the peer review conference proceedings
- the consideration of a full paper published in the proceeding to be judged a best-paper of the conference and published subsequently in a special conference issue of the *International Journal of Risk and Contingency Management*

### Research Scope

We would like to invite you to contribute papers related to any of the following topics. We welcome papers addressing any relevant topic within the broad theme of the conference, including but not necessarily limited to the following:

• Risk management in supply chains	• Canada and U.S. supply chain and border issues
• Use of lean and six sigma in supply chains	• Supply chain efficiency
• Customer relationship management	• Logistics/Reverse logistics
• Supplier relationships and negotiations	• Information technology in supply chains
• Supply chain strategy and integration	• Global issues in supply chain management

We also encourage submissions that provide a clear link to important and interesting teaching and learning applications in supply chain management. Appropriate areas could include:

- Pedagogical approaches & curriculum issues in supply chain management courses
- The integrating of technology in supply chain management courses

Accepted papers will be included in the peer reviewed 2012 Global Supply Chain Management Conference Proceedings and shall be considered for publication in the *International Journal of Contingency and Risk Management*. **Authors of the accepted papers are expected to register for and present their research at the conference in order to be published in the proceedings or the *International Journal of Contingency and Risk Management*.**

### Submission Guidelines and Review Process

- All research (whether an abstract submission for research to be presented or a full paper for publication in the conference proceedings) should be submitted in Microsoft Word format to: Brian Neureuther at [neureubd@plattsburgh.edu](mailto:neureubd@plattsburgh.edu). Be sure to include full author contact and mailing information.
- The papers will undergo a process of blind peer review to check their suitability for presentation at the conference and publication in the proceedings. During this peer review process, high quality papers will be denoted as possible candidates for conference best papers. Potential best-papers will then go through a second round of peer review as required for the *International Journal of Contingency and Risk Management*.
